

## TERMS AND CONDITIONS

Please ensure that you have read fully and understood the legal and corporate aspects relating to Homotoxicology consultation and the Health Detector scan session.

- The Health Detector Technology is a computer modeling of homeostasis based on magneto-optical bioresonance data obtained by scanning the patient's organs on the biophysical amplifier while using the patient's brain as a sensor and transmitter. Physiological load on the patient in the form of micro electric current, optical and audio frequencies and magnetic induction at a level of only 10% above the Earth's natural background produces biological response from each organ at the time in the form of an energy informational brain signal which is detected by very sensitive telemetric triggering bio-analyser. The output signals are contrasted with conventional signal amplitude processing.
- The Health Detector system is designed for non-invasive evaluation of homeostasis and should be regarded as **preliminary check up to detect the state of homeostasis**. Medical conditions including subclinical and co-morbid conditions are identified with up to 95% accuracy in soft tissue organs and up to 85% in bones, skin and eyes. The presence of dental metal crowns and metal amalgam in the patient's mouth will affect the accuracy of results.
- No physical health claims of any kind could be made regarding the use of the Health Detector devices as these units are strictly investigative, and any related services must be purchased with this understanding.
- The Health Detector scan does not serve as a substitute for any current medical diagnostics; however the analysis may reveal medical conditions of which you were not previously aware. In case of suspected acute infection or urgent requirement for conventional medical treatment (e.g. insulin administration) or surgery you will be advised to seek further medical care via NHS or private healthcare. The number of biomedical tests, e.g. Metabolic Genetic Pathway screen, Stool Pathogens test etc. are available via private laboratory with the practitioner's referral (see the list of lab services). Some biomedical tests like saliva acidity, blood glucose, cholesterol level, urine Multistix® test etc. are performed *in situ* at practitioner's discretion during the session.
- The Health Detector scan can NOT be performed on children under 6 years of age, pregnant women and people with genetic disorders affecting their mental/psychiatric health or those suffering from epilepsy, dyspraxia, autism or any mental/psychiatric condition. Those on long-term steroidal therapy, strong pain killers or recent antibiotics may produce false-negative for pathology results on the scan which will be taken into consideration by operator.
- Parental consent is required for any person under 17 on the date of his/her the Health Detector diagnostic session.
- Discussion of the Health Detector Technology theoretical basis does not constitute the Policy of this operation; however the basic explanation will be given to the patient before the scan begins. This is merely due to the focus of the consultation being the health assessment, not the technology itself.
- Patients attending the Health Detector diagnostic session should wear **single** light colour clothing on top and have nothing to eat or drink for at least one hour before the session and allow 10-15minutes to rest afterwards. No alcohol, drugs of medications (other than any necessary prescribed medications) should be consumed at least 24 hours prior to the session as these may affect the scan results. All jewelry, watches, waist belts with metal buckles should be taken off, and keys, mobile phones and coins should be removed from the pockets prior to the session.
- Any surgically removed organ will be graphically represented on the screen as a scarred tissue or a healthy organ as the system is NOT designed to recognise it. The Health Detector scans all organs and systems except for the muscular system.
- The 2-hour initial session will include evaluation of body's functional balance by the Health Detector scan and some biomedical tests (if necessary) followed by discussion, optional therapy by frequency compensation or anti-homotoxic medication prescription and consultation on life style and nutrition. The cost of saliva acidity and urine Multistix® tests is included in the consultation price. The cost of the other tests is NOT included.
- The Health Detector scan session is available with the choice of therapy: Frequency Compensation and/or Homotoxicology.

*Initial please:*

- Patients who underwent a therapy by frequency compensation may experience hyperactivity for up to four days followed by a short-termed exhaustion.
- The medication Prescription/Order will be posted to you during next few days after your session if required medication is out of stock at the time of your consultation. The cost of prescribed medication is NOT included in the consultation price.
- Homotoxicology, also known as Complex Homeopathy, is a system of holistic biological medicine known since 1952 that is based on a biochemical and homeopathic approach to help the body heal itself.
- Homotoxicology is all about the investigation and elimination of toxins in the human (*homo sapiens*) body called homotoxins that cause homotoxicosis (i.e. illness). Homotoxicology treats diseases by detoxifying the affected organs and systems with specific medicines combining homeopathic and pharmaceutical/biopharmaceutical ingredients in very low concentrations (i.e. in nanograms rather than milligrams as in pharmacology) prepared homeopathically therefore not suppressing symptoms or causing any side effects. However, in some chronic cases the patient may experience some initial aggravation of symptoms; these should be interpreted as a positive response to therapy and will subside as the therapy moves on. In case of over-sensitive patient the dosage may need to be readjusted.
- Anti-homotoxic medicines are available in the U.K. in the form of tablets, drops, creams, gels and ampoules only on prescription from a registered homotoxicologist.
- Anti-homotoxic remedy should be consumed within at least 15 min of eating, drinking and/or teeth brushing. Tablets should be slowly dissolved in the mouth. Tinctures should be diluted in bottled still mineral water prior to consumption.
- Senior and junior citizens benefit from 25% discounted price for a 2-hour initial session. The same applies to the follow up session which takes up to one hour and is usually arranged for approximately 4 weeks after the initial session to assess the effectiveness of the remedy and the therapy progression. Treatment of a long-standing illness usually requires several visits.
- The prices for biomedical tests *in situ* (**finger prick blood sample**) are as follows:

- Price for **foods intolerance and allergy 30-minute bioresonance test** (includes digestive system & blood cells screening) is **£150.00** for wheat, cow's milk, yeast, brazil nut, egg, chocolate.
- Payment is to be made either by cash or a cheque with a cheque guarantee card at the end of session.
